George Kennedy "16 Years as District Attorney"

On January 8, 2007, at noon, **George W. Kennedy** will bring his 16 year career as Santa Clara County District Attorney to a close. For almost 35 years, **George** has served at all levels of the District Attorney's Office from deputy district attorney to chief assistant district attorney. He was elected to the office of District Attorney in 1990 and has served in that role for four terms. During his career, he has personally handled most assignments in the office from motions and appeals to numerous murder and serial rape jury trials.



George is a graduate of USC Law School and Claremont McKenna College. He is the former president of the California District Attorneys Association and is currently chair of their Appellate Committee. **George** serves as a member of the California Commission on the Fair Administration of Justice and the California Council on Criminal Justice.

Among his accomplishments, **George** increased child support collections by 250% when he had that responsibility. His crime lab has the most prestigious accreditation and had early DNA capability. He formed a cold case unit and in-house innocence project in the early 1990's and developed specialties in such areas as child abuse and hate crimes. His government integrity unit has pursued numerous accusations and indictments against local officials. While **George** emphasizes vigorous prosecution of violent criminals, he has also focused on important community issues such as truancy and the representation of dependent children.

George is known through the justice community as a committed advocate for the victim. His work looking out for victims of crime, abuse, neglect and fraud has set standards which make Santa Clara County respected and copied throughout the state and across the nation.

The language arts we support have improved English literacy in both students and parents. Before school reading groups rival the chatter at any local Starbucks, and in fact the school has dubbed the morning program "Read Bucks Cafe."

While President of the Rotary Club of Pleasant Hill in 1996-97 three projects stand out. A water well and distribution system in Tegucigalpa, Nicaragua, an AIDS Clinic ambulance in Mangalore India, and a stateside immunization program in San Mateo County. All three projects leveraged Rotary International funds through their Matching Grant Program.

Betsy and Rich have hosted Group Study Exchange members from Denmark, and Rich says "Rotary has helped me join the world's international family of people and participate in their countries around the globe as if they were part of my own neighborhood."
